Sharon Lee Kustra, President of the Education Association thanked the board on behalf of the Association for not privatizing.

Joe Berg – President of Local 401 commented on his observations at the Freeholders meeting last week.

Carol Sabo stated that she stood behind the Cape May County Technical School's Education Association.

Bob Antonelli, NSEA thanked the board for their commitment to make this situation right.

Monica Reider mentioned that Stacy Evans is leaving the Cape May County Technical School District and thanked her for all of her hard work and that she would be missed. Dr. Hudanich recognized her family.

Sam Kelly, prior business agent for public employees of Cape May County, commented that the outcome reached shows the progress made with staff relations.

Cieran McGreevy's daughter thanked the board of education for resolving this issue.

Mr. Boyd reported that he mistakenly put his home address on his ethics disclosure form, however, someone took that information and posted it on Facebook and that they committed a crime. Mr. Boyd read the statute (2C:20-31.1) whereby any person recklessly exposing private information of a police officer or a retired police officer or a family member is a crime of the third and fourth degree. He expressed the anxiety and concern that this act caused his wife. Dr. Hudanich publicly apologized to Mr. Boyd and informed the audience that when the business of the board is not conducted in the boardroom but rather on social media we lose credence and validity of the issue. She also apologized to Mr. Boyd for the crime that was committed against his family over this issue.
