#### **REVENUE & EXPENSE**

The Board discussed the 2021/2022 proposed budgets for both districts. Revenues, appropriations, recap of balances and per pupil cost calculations were reviewed.

Mr. Merson inquired about the effect of COVID-19 on the custodial budget and if security concerns were addressed. Administration from both districts indicated these issues were addressed and did not require additional staff.

On the motion of Mrs. Elwell, seconded by Mr. Merson, the resolutions for the 2021-2022 proposed budgets for the Cape May County Special Services School District and the Cape May County Technical School District for submission to the Cape May County Office of Education were approved by roll call vote. The Cape May County Technical School Districts resolution was amended to include estimated Fund 20 scholarship account and estimated student activity account for submittal to the county office.
